PLEASE READ: To be eligible for a FAA Commercial Pilot License, you must be at least 18 years of age, you must be able to read, speak, write, and understand the English language, and you must pass a medical examination from an FAA certified examiner. We will accept students into the course who are at least 17½ years of age as they will reach their 18th birthday before the completion of the course.

*** Bel Air International limits the enrollment to only 45 students at a time, which makes the course duration of 7 months perfectly attainable.**
